The King Edward VII's Hospital Sister Agnes operates from a single location, King Edward VII's Hospital, which is a 52 bed independent charitable hospital in central London with a 4 bed critical care unit, four operating theatres, diagnostic imaging and outpatient services. It provides its regulated activities to adult patients aged 18- 65 and 65+ years.

The Hospital employs 359 members of staff.

The charity provides support to veterans through subsidised treatment and the Hospital Pain Management Programme

The hospital has four operating theatres and provides elective surgical procedures to patients in the following specialities:

### Treatment of Disease, disorder or injury

The hospital also provides treatment of disease, disorder or injury to adult medical patients including those undergoing endoscopy and End of Life Care. The hospital can also provide Critical Care up to CCU level 3 if required.

The hospital has an outpatient centre for consultations, minor procedures and phlebotomy.

### Diagnostic Imaging

King Edward VII's Hospital provides diagnostic imaging to adults including x-rays, CT and MRI for both inpatient and outpatients

## Family Planning Services

The hospital implants intrauterine devices during gynaecological procedures usually for menstrual disorders in line with NICE guidance.
