



## Statement of Purpose

### King Edward VII's Hospital Sister Agnes

Established in 1899, King Edward VII's Hospital is an independent charitable hospital with a long history of providing the highest quality surgical and clinical care, using advanced medical techniques. King Edward VII's Hospital is governed by Royal Charter and regulated by both the Care Quality Commission and Charity Commission.

The provider, King Edward VII's Hospital Sister Agnes operates from a single location, King Edward VII's Hospital, in the centre of London, which consists of three buildings. Main hospital building located at 5-10 Beaumont Street; King Edward VII's Medical Centre (Outpatients) is opposite at 54-55 Beaumont St; Agnes Keyser house (Administration – staff only) adjacent to King Edward VII's Medical Centre. The main hospital is a 52 bed, independent charitable hospital with a 4 bed critical care unit, four operating theatres, diagnostic screening and imaging and outpatient services, including GP services. It provides regulated activities to adults aged 18 - 65 and 65+ years. It also provides diagnostic screening and imaging and outpatient services to Young People aged 16 and 17 years.

The Hospital employs 335 members of staff.

The charity provides support to military veterans through subsidised treatment and the Hospital Pain Management Programme

King Edward VII's Hospital provides regulated activities to adults 18-65 and 65+years.

### Surgical procedures

The hospital has four operating theatres and provides elective surgical procedures to patients in the following specialities:

Urology	Gynaecology	Colorectal
Orthopaedics	Ophthalmology	Bariatric
Breast surgery	Plastic surgery	ENT

### Treatment of disease, disorder or injury

The hospital also provides treatment of disease, disorder or injury to adult medical patients including those undergoing endoscopy and End of Life Care. The hospital is equipped to provide Critical Care up to CCU level 3 if required.

The hospital has an outpatient centre for consultations, including GPs, minor procedures and phlebotomy. The hospital will provide consultations and phlebotomy to Young People aged 16 and 17 years but not for interventional procedures.

### Diagnostic and screening procedures

King Edward VII's Hospital provides diagnostic and screening to adults including imaging such as x-rays, CT and MRI for both inpatient and outpatients and outpatient services only, to Young People aged 16 and 17 years.



## Family planning services

The hospital implants intrauterine devices during gynaecological procedures usually for menstrual disorders in line with NICE guidance.
